We have no obligation to consider a request placed outside 14 days of the date of delivery or the latest estimated date of arrival.

You can cancel an order within 8 hours of the time you placed it (Same Day Cancellation).

You can also withdraw from a purchase at any time between the time of purchase and 14 days of receipt of the item. If purchased items have been shipped before Wish receives a cancellation, you are responsible for the costs of return shipping.
